

Terms and Conditions

1. Acceptance of Terms

By accessing or using Coin Crusade, you agree to be bound by these terms and conditions ("Terms"). If you do not agree to these Terms, you may not access or use the game. These Terms constitute a legal agreement between you and ChainWars.

2. "As Is" Use

You acknowledge and agree that Coin Crusade is provided on an "as is" and "as available" basis. ChainWars makes no representations or warranties of any kind, express or implied, as to the operation of the game, its content, or any information made available by or through the game. You use Coin Crusade at your own risk.

3. Skill Game and Non-Gambling

Coin Crusade is strictly a skill-based game and does not involve gambling. By using the game, you affirm that you are participating in a skill game and not a game of chance. You further affirm that you are over the age of 18.

4. Jurisdictional Compliance

You are responsible for ensuring that your use of Coin Crusade complies with all local laws and regulations. You may only use the game if it is lawful in your jurisdiction. ChainWars is not responsible for your compliance with local laws and regulations.

5. Risks and Responsibilities

ChainWars reserves the right to terminate or suspend your access to Coin Crusade at any time, without notice and for any reason, including, but not limited to, a breach of these Terms. Upon termination, all provisions of these Terms which by their nature should survive termination shall survive, including, without limitation, ownership provisions, warranty disclaimers, indemnity, and limitations of liability.

12. Governing Law and Dispute Resolution

These Terms shall be governed by and construed in accordance with the laws of the jurisdiction in which ChainWars is headquartered, without regard to its conflict of law principles. Any disputes arising out of or in connection with these Terms or Coin Crusade shall be resolved through binding arbitration in accordance with the rules of the relevant arbitration association. The arbitration shall take place in the jurisdiction of ChainWars' headquarters, and the language of the arbitration shall be English. You agree to initiate any dispute by contacting ChainWars directly and providing a detailed description of the issue. ChainWars will then have an opportunity to resolve the dispute informally before arbitration is initiated.

13. Privacy Policy

You agree to the collection, use, and sharing of your information as described in our Privacy Policy, which is incorporated into these Terms by reference. Please review the Privacy Policy to understand our practices.

14. User Account Security

ChainWars takes reasonable measures to protect user data from unauthorized access, use, or disclosure. However, you acknowledge that no internet transmission is completely secure, and ChainWars cannot guarantee the absolute security of your data. In the event of a data breach, ChainWars will notify affected users as required by applicable laws and regulations.

15. Prohibited Conduct

You agree to use Coin Crusade in a manner that is lawful and respectful to other users. You shall not:

- Use the game for any unlawful purposes or to conduct any unlawful activity.
- Harass, abuse, or harm other players or any personnel of ChainWars.
- Post or transmit any content that is abusive, defamatory, obscene, or otherwise objectionable.
- Use the game to transmit or distribute any unsolicited bulk or commercial messages (spam).
- Attempt to hack, decompile, or otherwise interfere with the integrity or proper working of the game.
